Code of Conduct

- You must comply with EPA and WCPA rules including dress code (see overleaf) and the World Anti-Doping Code which can be viewed at www.wada-ama.org
- Update the WCPA Secretary with any changes to your contact details
- All players will be expected to referee/time keep when required at matches
- If you are provided with a current County Shirt you are expected to wear it at all matches. If you are ordered a team shirt and do not wear it at matches you will be asked to repay the costs involved and could be excluded from playing
- Make a genuine effort to attend County practices
- If offered transport to matches (by either minibus or private car) respect the driver, passengers, vehicle and be prepared to contribute towards fuel/parking costs

Communication - Social Media

The effective use of communication is essential to both the efficient operation of the WCPA and to protecting the image and reputation of the association and its players. By signing this code of conduct you are adhering to the following social media communication principles:

- You must take care in your use of communication. Remember individuals have the right to view their own written and electronic personal information under the <u>Data Protection</u> <u>Legislation</u>.
- You must not knowingly access, display or participate in distributing material that is
 illegal or which another person may find offensive, particularly so in respect of race,
 creed, sex, marital status, age, physical or mental disability, political opinion, religious
 or philosophical belief or sexual orientation. Whether sent by post, fax, text, electronic
 mail, messaging systems or posted on a social networking site, such material can be
 distressing and intimidating.
- Communication must not be used to conduct any form of harassment or intimidation to the association for example, by sending false or persistent messages for the purpose of causing annoyance, inconvenience and needless anxiety to others.
- All County associated Facebook and any other social media groups (including WCPA Sunday Night League and Wiltshire County Ladies) are designed to be a platform for notification purposes by the County to the followers.

• In the event that a player or member bring the association into disrepute they will be suspended from all groups with immediate effect until a decision can be made by the WCPA Core Committee on whether this ban will be permanent or for a limited period.

I understand that action may be taken by the WCPA, Region 5 or the EPA in the event of any dispute or as a result of any of my actions.
